The Virginia Dressage Association (VADA) will be hosting the "Great American Insurance Group/USDF Region 1 Dressage Championships and VADA Fall competition" on 8-11 October 2020, at the Virginia Horse Center, Lexington, VA. It will be under vastly different circumstances from the previous years. It will be the ultimate goal by the competition management to provide a safe environment for competitors, judges, volunteers, and staff by complying with COVID-19 protocols. VADA has made modifications aligned with USEF/USDF, State, and Virginia Horse Center guidelines for the October 2020 show format. There will be a limited number of vendors inside/outside with proper social distancing, an online show program, no spectators, wearing masks are required, and a limited hospitality venue. In July, VADA hosted "Dressage at Lexington" with tremendous success. We had over 200 competitors thrilled to be back showing. The Virginia Horse Center did an extraordinary job ensuring a safe environment. Everyone entering the horse park was required to complete a COVID-19 waiver, daily temperature check at the front gate, and grounds cleaning. There were a total of 6 vendors present, that commented how well the show was orchestrated under the new guidelines, felt extremely safe, observed competitors taking everything in stride in the new normal and wearing masks, and sales were profitable. It is our hope those vendors who were reluctant to participate in July will reconsider attending in October. ### Scholarship Report

I recently was awarded \$400 for an SVDA scholarship. I used those funds to get some lessons from our fabulous local "S" judge, Kathy Rowse, and fabulous "R" judge, Carol Bishop, who comes monthly to our area from her home in Gastonia, NC.

It has been quite a while since I have ridden with Kathy. Kathy always has many fun and helpful exercises for your position, of which I was in dire need. Thanks to old age and just plain old bad habits, I don't sit evenly so we did some seat work to get things more balanced and moving freely. Then we worked on getting Siam's shoulders and hips to move left and right while maintaining a steady balance. We also worked on keeping her shoulders straight while changing bend and flexion; it's so easy to overbend the neck and let the balance fall down to the outside. Of course one crucial element is to keep your reins shorter. I think I have heard that before once or twice!

Kathy also helped me with my understanding of the walks. In third level and above, the extended walk is demonstrated. Fortunately, my horse has a clear and adjustable walk so we were able to go back and forth between the free and extended walks so that Kathy could explain and I could feel what was correct vs. incorrect for both. It doesn't really matter which walk you are doing – in any level, you should ride it every step: maintain good activity and stretch – and never just consider it "break time". This was an excellent educational opportunity for me to not only improve my riding, but also improve my judging.

In previous lessons with Carol, Siam was starting to offer a few half steps, which for me is something new and very exciting. We have been working on making her go really sideways and always stepping under rather than just pushing over. As she became more generous with her hind leg activity, we started adding some quarter turns while still insisting that she step well under. As these got stronger and more balanced (and the rider got braver), we progressed to a 8 – 10 meter half turn and were rewarded with a couple of "passage-y" steps. It was really fun to feel a horse come up through their shoulders like that! Carol also constantly reminds me to do my transitions on a small circle which helps me keep my big horse better balanced instead of going splat and on the forehand.

I am grateful for the vast dressage expertise we have at our fingertips. I have had a lot of excellent and productive lessons from a large amount of clinicians but the lessons that I take from judges such as Kathy, Carol, and Janice Mumford are the ones that challenge me the most and keep me moving forward.

## GEORGE WILLIAMS CLINIC

### (Patience on a Trampoline)

To meet George Williams is quite an opportunity! To ride with him is an honor! As he is the US Equestrian Dressage Youth Coach and member of the FEI Dressage Committee, I was a little intimidated to say the least. I mean, I'm a 50 something year old lady with my 22 year old spicy and smart purebred black Arabian and we are just starting our 1<sup>st</sup> level year. But as soon as I started watching him instruct other riders, I immediately relaxed. And that was a big part of what we worked on, relaxation.

Relaxation is one of the foundations for training in dressage and I found out immediately how helpful it can be. George was definitely the person to teach it. He was very kind and patient. We started out by suppling and bending at the walk and trot to get Rodeo rhythmic and through his back while pushing underneath with his hind leg. George had us do some slight inside flexion with inside leg aid while on a 20 meter circle encouraging Rodeo to step with his hind leg underneath while also softening his ribcage, neck, and over his back. Once Rodeo was soft, we worked on pieces of the test from 1<sup>st</sup> level test 3.


My favorite exercise/tool and take away was for the canter to trot transition. In 1<sup>st</sup>-3 within the test there is movement that asks for that specific transition (FXH canter with a change of lead through the trot over X). George had us ride it a couple times. Rodeo would get strong at the canter at the beginning of the movement and each time we would go for the transition to trot, I had to struggle, wrestle, and really pull on the reins (which I hate doing) and he would throw his head up because he just insisted that when you go across the diagonal at the canter it's supposed to be a lengthening...NOT a canter transition to trot. Uggghh! But George would reassuringly say, "That's alright, that's ok" and patiently help me adjust myself and my overly smart and spicy Arabian.

So to fix this we did this exercise. We cantered the short side and down the diagonal as usual. But before we got to the transition we prepared with several half-halts, slowing my seat down, then down to the trot and IMMEDIATELY halt. No matter how ugly it looked or felt, no matter how much Rodeo flipped his head up and insisted, George said, "its ok. It's alright". We halted immediately. We did this several times repetitiously. Then walked off down the other short side of the arena, picked up our trot, then canter, and down the diagonal again in Canter, trot, and halt fashion. After several times of this, we got softer and softer and easier and easier. By the end of the exercise we were able to put it together and Canter trot canter with no head tossing and complete relaxation. It was wonderful.

So wrapping this up, I bet you are all wondering about my title. Well, if anybody knows my Rodeo, they know he has one of the springiest trots around. And well, George decided I needed to start sitting Rodeo's trot because in 1<sup>st</sup> level it's an option to sit the trot and 2<sup>nd</sup> level you MUST sit the trot... Let's just say that my first attempt for sitting Rodeo's trot during most of the clinic was...well...like being a bobble-head on a trampoline with uncontrollable seizures throughout my body! George watched me, smiled and with kind patience, carried on his instruction saying, "Its ok! It's alright". I went away from the clinic feeling inspired! George Williams is a true horseman and I can't wait to go to his next clinic!

Canter Trot Halt Exercise (Can be done on any diagonal and straight line)

Canter short side, then diagonal HXF. Trot at X. Then Halt after a few strides of trot. Halt should be maintained for a few seconds. After Halt. Be sure horse is supple and round then walk off straight for a few strides.

Lehua teaches students of all levels and ages with a special interest in helping riders ride their own horse up the levels and push past any mental barriers. #### VADA MINUTES - CONFERENCE CALL MEETING 09-23-2020

The meeting was called to order at 8:03.

Anne Draine made the motion to accept the minutes from the last meeting. Sandy Toby seconded, and the Board approved unanimously.

**Treasurer's Report** – Jessie reported that the balance is around 200K but that's without a lot of show expenses and includes show income.

GAIG Show: October 8-11- Tina reported that there are no USDF finals so we want to make this show special. Dianne reported that there are number of new COVID requirements- two people will act as compliance officers monitoring social distancing and the mask requirements. We will have several more volunteers for eyes on the ground. There are more specific requirements on who can attend- it's essential personnel only. No extra family members and this will be monitored in the barn area. It is a full seven ring show with four rings of championship rings which is a first. This becomes a challenge with judges and scribes, especially on the hill. We will stage 10x10 commercial tents as needed with partitions and weather protection sides. VHC has more permanent food trucks and the café in the coliseum will be open. Alison Campbell will do volunteer lunches with online ordering. We are changing protocol for the awards ceremonies which will involve competitors dressing their own horses with the ribbons and then come ready for the ceremony. There will be no dog costume contest. Rachel is still looking for a lot of volunteers. Each person will have their own hotel room. She needs a few more scribes and runners but especially stewards. There are also spots for helping volunteer check in, food service and awards. Sheli reported that participation in the awards ceremonies is encouraged but not mandatory and riders must wear masks. There will be more specific times to limit the amount of people will be in the area. We will announce when and where people can pick up the ribbons and awards. When competitors pick up their ribbons, they will be asked if they want to attend the awards ceremonies. Nancy Lowey and Nancy Doody are winding up their sponsorships. They raised almost \$8K with 15 vendors as of now. Tina reported that we have 1017 rides as of now with four rings on Thursday, and seven rings starting on Friday with three championship rings. Saturday will have the night class championships and four championship rings. Sunday will be six rings with four rings being championship classes.

**2020 USDF Annual Virtual Convention:** If you are a paid VADA member, you can attend all the meetings. Visit the USDF website for more information.

**Chapter Updates:** C'ville is planning another schooling show before year end. Fredericksburg had a successful licensed show. NOVA also had a successful licensed show in August and is having their championship schooling show on October 31<sup>st</sup>. SE is having a clinic this fall and is also planning to have their annual membership banquet in person. SW is having an eventing combined schooling show Oct 18<sup>th</sup> and a cavelleti schooling show the 24<sup>th</sup>. They are going to have a trail ride as part of their awards meeting.

2021 VADA Banquet: Joanne Collins is working on ideas for awards.

**Shel Gafford Award:** Sheli is the coordinator. She only wants email submissions. She'll then consolidate and send to each chapter. Each chapter is then responsible for submitting the chapter result back to Sheli.

The meeting adjourned at approximately 8:54pm

# **REGIONAL CHAMPIONSHIP'S AWARDS CEREMONY PROTOCOL**

- A mounted awards ceremony will be help for each Championship class.
- The times for each awards ceremony will be posted on <u>www.horseshowoffice.com</u> no later than Wednesday noon as well as throughout the barns.
- Participation in the awards ceremony is strongly encouraged, especially for class champions and reserve champions, but is not mandatory.
- Riders not intending to participate in their awards ceremony must notify the VADA representative at the time they pick up their ribbon/award.
- Riders placing in a championship class **must** pick up their ribbon and if applicable, other awards **PRIOR** to their designated awards ceremony Awards pick-up will be in the Show Office. Note that all tests are picked up at the Awards Table on the 2<sup>nd</sup> floor of the Anderson Coliseum.
- Riders not intending to participate in their awards ceremony must notify the VADA representative at the time they pick up their ribbon/award.
- Riders participating in their awards ceremony must arrive in the small warmup area adjacent to the Anderson Coliseum 5 minutes prior to their designated award ceremony time.
- Riders/horses must be in proper show attire, with ribbons affixed to the right side of the bridle. Instructions for securing ribbons will be provided. Leg wraps are permitted.
- Riders may choose to participate in the ceremony on any horse, but horse and rider must be in proper show attire as described above.
- An unmounted rider is permitted with prior permission from the Awards Coordinator. No unmounted horses allowed. Rider must be in proper show attire.
- All persons participating in the awards ceremony, INCLUDING RIDERS, must wear masks.
- All riders participating in an awards ceremony will have their photo taken and will then have the opportunity to participate in a victory lap should they so choose or may exit the coliseum prior to the victory lap.

# Virginia Dressage Association (VADA)

VADA Rules, Guidelines, and Best Practices for its competitions at the Virginia Horse Center under current social distancing and other Federal, State, and Local Requirements.

### Updated September 20, 2020

This is a working-document for VADA-Specific protocol to ensure the safest environment possible for our competitions. We will continue to update this protocol as we receive updates and information from USEF, USDF, and local authorities.

# VADA 2020 COVID-19 Rules, Guidelines, and Best Practices

VADA has prepared the following list of Rules, Guidelines, and Best Practices in preparation for VADA hosted 2020 competitions. The objective of this document is to familiarize competitors of COVID-19 protocol that must be adhered to at all VADA hosted competitions. Failure to follow the guidelines may result in expulsion from the show grounds.

The VADA competition management has taken into consideration the size of Virginia Horse Center, and the number of attendees, but have concentrated our efforts and protocol requirements in the areas that will cause the greatest challenges for social distancing - Show Office, Stabling Area, and Warm-up areas.

We believe these guidelines are well within our scope to institute and enforce during our competitions. We will update these guidelines as needed based on State and Local Government requirements and/or recommendations from other local environmental health and public health agencies. Updates will be posted at VADA website <u>virginiadressage.org/</u>.

### VIRGINIA HORSE CENTER ACCESS – COVID-19 WELLNESS

- 1. Any person with known or suspected symptoms of COVID-19 or who has been exposed to a person with symptoms of COVID-19 (cough, shortness of breath, or fever) should follow self-quarantine protocol or will be barred from or removed from the grounds.
- 2. All Individuals should monitor their temperature daily and should not enter the premises if presenting with a temperature of 100.4 or higher.
- 3. All individuals, including participants, VADA competition staff, officials, and volunteers, **must** wear a mask or face covering while on the show grounds. The only exception is when mounted on a horse. Handlers in DSHB classes are not required to wear mask or face covering when inside the competition area. If you have a medical/ADA issue, refer to the USEF Action Plan for the procedure to document your issue and receive USEF dispensation.
- 4. Upon entry into the horse center, the VHC staff will request everyone to complete a health check questionnaire, sign a VHC wavier, and have temperature taken by a VHC staff member. Please allow yourself ample time for this process.
- 5. All individuals should monitor their temperature daily and should not enter the premises if presenting with a temperature of 100.4 or higher.

- 6. All competitors and support personnel are responsible for monitoring their own personal and family health prior too, during, and after attending a competition. If anyone who was present on the competition grounds test positive for COVID-19 within 14 days of the conclusion of the competition must notify VADA Safety Coordinator (Dianne Boyd, 703-850-9704) immediately.
- 7. The competition is only open to competitors, essential support personnel (e.g., owner, trainer, coach, parent, one groom/assistant), completion staff, officials, service providers, and volunteers. All support personnel associated with a horse must be listed on the entry form and sign the USEF waiver. NO other family members, relatives, friends are allowed on the show grounds.
- 8. Barn access is restricted to essential personnel associated with a horse, vets, braiders, night watch, Show Staff/Officials.
- 9. NO SPECTATORS will be allowed on the show grounds.

## ARRIVAL AND CHECK-IN

- 1. Following VHC health assessment at the front gate, proceed directly to the VHC Stable Office to obtain a stall assignment(s) and to complete the emergency contact form. Along with receiving stall assignment, a VADA representative will be present in the Stable Office Lobby to issue a competitor package. In the event an entry is not complete, contact Bettina Longaker (text/phone 540-222-5850) to set up an appointment to finalize entry. Please note the show office will not be open to competitors. *Appointment only*.
- 2. Ride times will be posted on the HorseShowOffice.com horseshowoffice.com/
- 3. Class results are available on HorseShowOffice.com <u>horseshowoffice.com/</u> and via text messaging. Note: To receive text messaging feature contact Bettina Longaker (text/phone 540-222-5850) for set-up assistance.

### SHOW GROUNDS FACILITY

- 1. Practice social distancing (6' feet between individuals) at all times. Do not congregate.
- 2. Immediate Household Groups must be identified by filling out the Immediate Household Identification Form and receiving an identifying wristband. This will permit those individuals to be closer than 6 feet. Masks **MUST** still be worn.
- 3. All individuals should frequently wash hands or use hand sanitizer with 60% alcohol. Hand washing and disinfection stations are available throughout the show grounds.
- 4. Restrooms, touchpoints, and common areas will be cleaned by VHC personnel and sanitized throughout each day of the competition.

### STABLING

- 1. VADA will arrange stabling so there is the appropriate social distance between trainer groups. Use only your entrance to your aisle to access your stalls. Do not enter aisles/stabling areas of other trainer groups.
- 2. All individuals must wear mask or face covering, maintain social distancing, and limit group size to ten (10).
- 3. Encourage handwashing or hand sanitization before entering the stabling area. Sanitization stations will be located throughout each barn.
- 4. VHC personnel will regularly clean and disinfect high contact areas in each barn throughout the day. Do your part to keep the barns clean and dispose of trash in receptacles.
- 5. Trainers are responsible for the conduct and adherence to the protocols for their clients and staff.
- 6. Groom and tack your horse in the stall. Not in the barn aisle. Mount and dismount outside the barn.

## SCHOOLING AND WARM-UP RINGS

- 1. Competitors must check in with the ring steward and adhere to show protocols.
- 2. Schooling and warm-up rings will be monitored by a ring steward to ensure rings do not become overcrowded and social distancing practiced.
- 3. During competition hours, rings will be limited only to riders warming up for the upcoming class.
- 4. Trainer and/or support personnel coaching a rider in the competition area must be mindful of practicing social distancing and other groups.
- 5. All individuals must wear a mask and/or face covering at all times on the show grounds unless mounted.

### **COMPETITION AND EQUIPMENT CHECKS**

- 1. Show braiding is optional.
- 2. Readers must wear his/her mask to read the test to the competitor.

3. A Ring Steward will make a visual equipment check for a prescribed number of class competitors. NOTE: ALL competitors in a Championship class will be checked. There will be a designated whip measuring area located on the fence with tape defining the allowed whip length. If any questions arise regarding equipment checks, a TD will accompany the competitor back to the barn and/or a selected area to discuss the issue.

### **OPEN CLASS AWARDS**

- 1. Open Class Awards are located on the concourse near the Show Office end of the coliseum.
- 2. ALL tests (both Open and Championship) will be picked up with the Open Class Awards.
- 3. All individuals **MUST** have Class Number to pick-up test(s) to minimize competitor/volunteer interaction and expedite the process.
- 4. Social distancing will be practiced with signs located at the entry to the awards area outlining social distancing requirements and test pick-up procedures. There will be social distance floor decals/tape defining the 6' separation as well as direct guidance for "IN and OUT" of the Awards Area.
- 5. A maximum of 10 individuals in line at one time practicing social distancing. If the number exceeds, individuals will be kindly asked to return at a later time.
- 6. Designated Awards area hours are 9:00 a.m. TBA (1 ½ 2 hours) after the last class for the day. Tests not picked up for that day will be scanned/emailed to competitors.
- 7. Ribbons will not be mailed.
- 8. All individuals must wear a mask and/or face covering to pick up test, prize, and ribbon.
- 9. Gloves are available to wear for picking up test, award, and ribbon.
- 10. Awards tables will be regularly sanitized throughout the show.

### GREAT AMERICAN/USDF CHAMPIONSHIP AWARDS

- 1. Great Ameican/USDF Championship Awards and Ribbons (but not tests) Pick-Up will be in the Show Office.
- 2. Awards Ceremonies will be held but are not mandatory. Please let the Awards Coordinator know if you will be attending.
- 3. Riders are responsible for picking up their ribbons and awards prior to their awards ceremony so they can dress their horses.

# **COVID-19 Situation Protocols**

## Arrival at Virginia Horse Center

- Virginia Horse Center personnel will check temperature and ask health check questions of all participants arriving at the facility each day
- If a participant has a temperature of 100.4° or above, exhibits symptoms of COVID-19 or has been exposed to someone with COVID-19 or symptoms, they will be asked to leave the facility immediately and not be allowed beyond the front gate.
- If participant requests additional evaluation, the EMT will be called to evaluate the participant further, including verbal questions and additional temperature evaluation. EMT shall determine if participant had a temporary situation and will be allowed to come on the show grounds.
- If a participant is turned away, competition management will immediately inform the USEF TD and USEF office.
- Each participant permitted to come on the grounds must sign a facility waiver and complete a health check questionnaire.

## **During the Competition**

- If a participant is notified of potential contact to someone with a positive COVID test, they should immediately contact Show Management or the EMT.
- If a participant experiences signs of illness or injury, they should immediately contact Show Management or the EMT.

- If the EMT determines that the symptoms are potentially COVID-19 related, the patient will be moved to the VHCF Isolation bus for further evaluation.
- If transportation to nearest medical facility is needed for evaluation and testing, EMT will arrange for local EMS transport.
- Safety/COVID-19 Resource Officer will coordinate with the affected participant's Emergency Contact/Trainer (if Rider) to determine actions needed to facilitate the participant's departure from the show grounds.
- Safety/COVID-19 Resource Officer will coordinate with VHC personnel to determine needed disinfection of areas where the patient was on the show grounds.

## **After Competition**

• Any participant, including staff, officials, and volunteers, who experiences potential COVID-19 symptoms or is tested positive for COVID-19 within 14 days of leaving the competition must immediately notify the Show Manager, Dianne Boyd,

## **Communication Protocols**

- Show Management will maintain current and emergency contact phone numbers and emails for all show participants.
- Communication will be via text, email, Show website to all participants. Separate communication will be made to the facility, USEF and local health officials
- In the event of an incident:
  - Safety/COVID-19 Resource Officer will notify any other participants that have been in contact with the affected individual and recommend that they self-quarantine for the next 14 days.
  - All other participants that have been at the facility will be notified by email that a
    participant has exhibited COVID-19 related symptoms or tested positive for COVID-19,
    keeping the person's identity protected. The communication will include what steps the
    show management is taking to protect the health of the other participants.
  - Communication of the incident will be provided to the USEF.
- For any incident, the Show Manager is the key contact for situation analysis and decision making.
- The Show Manager in collaboration with the VADA President will lead media activities and all external communication as well as respond to rumors on social media.

# Training

- Training will be provided prior to the start of the show.
- Training material consists of web-based documents for the VADA COVID-19 Guidelines and Rules, the VADA COVID-19 Emergency Response Plan, the VHCF COVID-19 Rules and Guidelines and the VHCF COVID-19 Response Plan.
- Zoom calls will be held with each participant group to go over all the required materials and answer any questions.

# **Enforcement Authority**

Show Management, the USEF Technical Delegate and VHCF staff have the authority to deny
access to participants who are showing COVID-19 Symptoms and to remove anyone from the
grounds who does not adhere to all rules and regulations.

 The Show Manager, in consultation with the USEF Technical Delegate has the authority to disqualify any participant for not following USEF rules and to ask VHC Security to remove them from the grounds.

# Regional Schooling Show Awards Program Rules

## **General Information:**

- 1. Program year is December 1 through November 30.
- 2. Scores may be earned in any USDF region.
- 3. Late nominations, applications and results submissions will not be accepted.

### **Rider Eligibility & Requirements:**

- 1. Rider must have a USDF Group Membership that is recorded by the Group Member Organization (GMO) at the time the scores are earned.
- 2. Riders affiliated with an International GMO must declare a USDF region.
- 3. Owner must have at least a USDF non-member number at the time the scores are earned.
- 4. Horse must have at least a USDF Horse Identification Number at the time the scores are earned.
- 5. Rider must submit a one-time yearly online nomination and \$35 nomination fee for each horse/rider combination no later than 14 days after the last day of the first competition. The nomination fee must be paid annually.
- 6. Riders may change their division status during the program year. A rider's status will be determined at the end of the program year.
- 7. Rider must submit scores to USDF online no later than 21 days after the last day of the competition.
- 8. Only USDF members in good standing are eligible to compete in the USDF Regional Schooling Show Awards Program and receive awards.

### Award Divisions & Levels:

- 1. Four award divisions will be recognized per region:
  - a. Open: from the beginning of the calendar year the rider reaches age 22, not a USEF Adult Amateur (AA), not a non-professional.
  - b. Junior/Young Rider (Jr/YR): up until the end of the calendar year the rider reaches age 21.
  - c. AA: from the beginning of the calendar year the rider reaches age 22 and possess a current USEF AA card.
  - d. Non-Professional: from the beginning of the calendar year the rider reaches age 22, not a current USEF AA, not a professional.
- 2. Seven levels (freestyle, pas de deux and quadrille not included) will be recognized per division. Exception: only 6 levels are recognized in the open division:
  - a. Introductory (only in Jr/YR, AA and non-professional divisions)
  - b. Training
  - c. First
  - d. Second
  - e. Third
  - f. Fourth
  - g. FEI combination of Prix St. Georges, Intermediate I, Intermediate II and Grand Prix scores.

- 3. Equivalencies listed in the current USDF Member Guide are eligible. Tests not listed as equivalencies will not be eligible.
- Preliminary standings will be ranked using a median of all eligible scores and will be available on the USDF website.
- 5. Final awards standings will be based on the rider's region of primary residence in the USDF database as of November 30.

### Score requirements:

- 1. Introductory Level:
  - a. Must have a minimum of five scores
  - b. From three different judges
  - c. From three different competitions
- 2. Training through Fourth Levels (levels may not be combined to meet requirements):
  - a. Must have a minimum of five scores
  - b. From three different judges
  - c. From three different competitions
  - d. At least one score must be earned from the highest test of the level
- 3. FEI Level (levels may be combined to meet requirements):
  - a. Must have a minimum of four scores
  - b. From three different judges
  - c. From three different competitions

### Prizes:

- 1. Up to ten placings per division/level will be recognized.
- 2. Ribbons will be mailed to the rider.
- 3. Certificates will be available online.

### **Competition Management Requirements:**

- 1. Any non-USEF-licensed/non-USDF-recognized competition may participate.
- 2. To participate, competition management must submit online application and \$25 participation fee to USDF at least 30 days prior to the start date of the competition.
- 3. The prize list must be submitted to USDF no later than 14 days prior to the competition.
- 4. Competition judges must be one of the following:
  - a. Current USDF L Graduate, with or without distinction (highly recommend USDF L Graduates with distinction), which has met USDF continuing education requirements and Safe Sport training. USDF L Graduates with distinction are eligible to judge FEI classes.
  - b. USEF or FEI-licensed or retired dressage judge.
- 5. FEI classes must be judged by USEF or FEI-licensed or retired dressage judges or USDF L Graduates with distinction.
- 6. Competition arenas must be in compliance with US Equestrian DR 126 for level 1 competitions.
- Competition results must be submitted to USDF via the USDF Electronic Results Submission Standard (ERSS) format (using the USEF Universal Spreadsheet Template) no later than 21 days from the end date of the competition.

### Airfield Conference Center Equine AGREEMENT

Airfield Conference Center (Airfield) ASSUMPTION OF RISK, RELEASE AND INDEMNIFICATION This document waives very important legal rights.

In consideration for Airfield Conference Center permitting me to participate in this Competition, and by signing the entry blank, I agree as follows: I AGREE that I choose to participate voluntarily in this Competition, as a rider, driver, handler, lessee, owner, agent, coach, trainer, junior exhibitor, or as a parent or guardian of a junior exhibitor. I AM FULLY AWARE AND ACKNOWLEDGE THAT HORSE SPORTS AND PARTICIPATION IN THIS COMPETITION INVOLVE SERIOUS RISK OF HARM INCLUDING, BUT NOT LIMITED TO, RISKS OF ACCIDENT, SERIOUS BODILY INJURY, INCLUDING DEATH, BROKEN BONES, HEAD INJURIES, TRAUMA, PAIN, AND SUFFERING, AND PROPERTY DAMAGE. I ASSUME ALL RISKS OF HARM TO ME, MY HORSE OR MY PROPERTY.

I AGREE for myself, my heirs, executors, administrators, successors and assigns to release Airfield Conference Center(Airfield), Virginia Polytechnic Institute and State University (Virginia Tech), the Competition, the facilities leased by the Competition and the owner(s) of the facilities, and all of their respective officers, officials, directors, employees, agents, personnel, volunteers, affiliated organizations and insurers (collectively, the "Released Parties") from any and all claims for damage, loss, or injury to myself, other persons, horses or other property belonging to me to the fullest extent permitted by law that arises out of or relates in any way to the Competition and my participation in the Competition INCLUDING, BUT NOT LIMITED TO, DAMAGES, LOSS, OR INJURY RESULTING FROM ANY ACTS, FAILURE TO ACT, NEGLIGENCE OR NEGLECT OF OTHER ENTRANTS, THE RELEASED PARTIES, THEIR CONTRACTORS OR INVITEES, as well as for theft, vandalism, fire, other casualty damage, or damage arising out of any defects in the premises.

By signing below as a parent or guardian of a junior exhibitor, I consent to the child's participation and agree to all of the above provisions, and further agree to assume all of the obligations of this Airfield Assumption of Risk, Release and Indemnification personally and on behalf of the child.

This Airfield Assumption of Risk, Release and Indemnification is governed by the Laws of the State of Virginia and is intended to be interpreted as broadly as possible. I agree that exclusive jurisdiction and venue (place) for any legal action against Airfield, Virginia

Tech, its officers, directors, employees, volunteers or agents shall be in the local district courts or the federal court of the State of Virginia. If any part of this agreement is determined to be unenforceable, all other parts shall remain effect.
