

VADA BOARD MEETING MINUTES 4-16-24 VIA ZOOM

Minutes: The minutes from the March meeting were approved by unanimous consent.

Treasurer's Report: Jessie reported that the combined balances are approximately \$204,434. This includes deposits for the L program but no expenses as well as the ribbon order for the year.

Membership Report: Sheli reported we currently have 422 members registered with USDF and another 60 that Beth is waiting on chapter payments to submit.

Purple Book: Nancy Doody has the Charlottesville, NOVA, Fredericksburg, and NE membership rosters and needs the rest of the membership chairs from the remaining chapters to submit to her by the 29th. As chapters add new members, the designated appointee from the chapter should send the information to Nancy Doody.

Chapter Grants: The updated criteria and changes have been incorporated into the program rules. Nancy Dood has put the forms and information on the portal and made this a paperless process. When chapters submit the form, it will be electronically sent to Beth for membership number verification. Nancy has also created a storybook (flipsnap) section to our website for the chapter writeups which will allow for an archive.

DAL: Dianne reported that the basics are all in place and the Nancys are working on sponsors and vendors. We will start to promote the show on social media to generate interest in not only the show and volunteering, but also the challenge classes. Rachael reported that the volunteer sign up is now live on the website. Chapters please make sure your members are volunteering if they can.



- Year-end awards banquet was well attended with a successful silent auction. SVDA was well represented in awards; great job everyone!
- Plans are underway for a Lilo Fore clinic in 2025, probably at VHC East Complex in Lexington. More details as they become available.
- Minutes from the most recent teleconference were forwarded.
- If SVDA would like VADA to list their shows on their website, send the dates and locations to webmaster Nancy Doody (her email is on the website).
- There is an upcoming L program, part 1 in December 2024, to be held at Old Raptor Farm, outside of Charlottesville.
- DVCTA is also running this program around the same time which may affect our numbers.
- Region 1 is looking to redesign the logo. See Facebook for submission information.
- Regionals will be held in Lexington, VA for 2024 and 2025.
- Finally, new rules for licensed shows have been posted to Facebook. Please read before you go.

- Welcome new board members: Susan Gaston, Membership; Deb Sweetman, Secretary; Shari Cutchins, Treasurer; Pinky Hipp, Member at Large.
- Entry fees were not increased during COVID and I do not believe it is needed to increase them. However, there is a need to add a convenience fee to the online show entries. The PayPal fees have drained the account over the past year. They charge SVDA 3.49% and 0.49 per transaction. This has been discussed with Robyn, Wendy, and Shari, it was felt that a \$5.00 fee would cover. The board unanimously voted to add the convenience fee.
- Other items that have impacted our budget:

Test printing costs between \$150.00 to \$200.00 per year.

IRS mileage has increased along with Port-a-Potty costs.

Wendy has gotten rid of Constant Contact which cost SVDA \$650.00 per year. She is looking for a better rate for our website.

SVDA did receive the chapter grant of \$1300.00 which helped with the clinic.

- Juniors need to pick a show to work. If that show is cancelled then they need to select another show in order to receive the profits.
- Board members are required to be paying and in good standing members as well as attend the membership/clinic meeting. If you have not paid your membership fees, please do so.

- Currently working on new banquet arrangements.

- Crescent Bay Pony Club application for Sanctioned Schooling shows by SVDA has been received and approved. They are hosting 4 shows and no conflict of dates with SVDA shows. Wendy and Sarah will post the following show dates to our website and newsletter: April 14, June 16, August 18, and October 20. Shows will be held at Northwest River Park.

- Currently there are 51 paid members.
- All the dues checks have been turned over to Cookie. Also the membership spread sheet will be forwarded in the first few weeks of the year.

Scholarships:

- Applications are due April 1, 2024.
- Robyn asked if anyone had used the scholarship money from last year. If not used, the individual can ask for an extension.

Juniors:

- Charlene
- We had a successful silent auction there were only 5 items that were not bid on during the auction. We raised almost \$900 through the auction (very good considering 1/2 as many attendants than previous years). Checks were given to Cookie to deposit (\$867).
- Cookie also deposited (\$260) money raised through the raffle at the SVDA Championship Show.
- The JR Team is planning to sell food/drinks and SVDA swag at the March/April SVDA shows and July/August/September Shows. The SVDA June show is the same weekend at the JR Team Championship and

the SVDA May show is the same weekend at MAD Fest (Several JR Team and parents will be at MAD Fest and unavailable).

- So far we have raised about \$1200 for the Junior Team Championship Show. We have approximately 9 JR/YR interested in participating which would cost approximately \$3150 to send all 9 including two classes, stall fee, team fee, team shirt and coaches hotel expenses.
- The Continuing Education in Judging Musical Freestyle had 25 auditors/participants (4 "r" / "R" / "S" Judges and 3 L-grads), two participants took and passed the test to receive their MFS Designation for judging. We made a small profit (\$143.61). Most participants paid through the PayPal account, there were 6 participants that paid day of the event via check on Venmo to Charlene. Checks/cash from the day of payment and receipts from the meal were provided to Shari Cutchins.


